### **SECTION 6 - ATTORNEY BONDS**

6.1 An attorney that posts a bail bond pursuant to Texas Occupations Code Section 1704.163 is exempt from the licensing and security requirements imposed by this Board and the Occupations Code. However, attorneys should be aware of the requirements of Texas Code of Criminal Procedure Article 17.11 stating, "Every court, judge, magistrate or other officer taking a bail bond shall require evidence of the sufficiency of the security offered; but in every case, one surety shall be sufficient, if it be made to appear that such surety is worth at least double the amount of the sum for which he is bound, exclusive of all property exempted by law from execution, and of debts or other encumbrances; and that he is a resident of Texas, and has property therein liable to execution worth the sum for which he is bound."
